Subject : **Suggested programmes and activities under Annual Action Plan- 2016-17**

3. **District NYK wise**, brief description against each of the suggested Core Programmes & Schemes viz. objective, number of Programmes, duration & month, level of programme, venue of the programme, number of Youth Clubs to be involved, number of participants, budget required, collaborating agencies and expected outcome, should be elaborated in the **enclosed proforma (Annexure-2)**.
4. The District NYKs may also **propose innovative programmes** based on needs and aspirations of local youth.
5. Further, all are requested to contribute by providing valuable suggestions with brief write-up for further improving existing Core Programmes and Schemes of MoYAS. It may kindly be noted that while providing inputs, the points at **Sl.No. 3** above should be covered.
6. Respective Zonal Directors should submit District NYK wise proposed targets in the **prescribed enclosed proforma** to NYKS headquarter: [mpsharmanyks@yahoo.co.in](mailto:mpsharmanyks@yahoo.co.in) **latest by 29<sup>th</sup> January, 2016** so that funds are sought from MoYAS accordingly and also help conducts these in a planned and transparent manner.
7. Besides, District NYKs Action Plan 2016-17, Zonal Director should also submit **Consolidated State/ Zonal NYKS Plan** to NYKS headquarter: [mpsharmanyks@yahoo.co.in](mailto:mpsharmanyks@yahoo.co.in) **latest by 29<sup>th</sup> January, 2016** in the **prescribed enclosed proforma (Annexure-3)**.
8. The submitted State/ Zonal and District NYK plans for the financial year 2016-17 would be put up before the Director General for his kind perusal and further directions.
