To: All Employees of NYKS

It has been noticed that the employees of NYKS are forwarding their representations in respect of matters pertaining to their service through MPs/VIPs.

The employees of NYKS are governed by CCS (CCA) Rules 1964 of Government of India, Rule 20 of CCS (Conduct) Rules has laid down that no Government Servant shall bring or attempt to bring any political or other influence to bear upon any superior authority to further their interest in respect of matters pertaining to their service under the Government. Rule 20 (4) of the said rule says that any high dignitary or Member of Parliament normally sponsors the case of an individual Government Servant only when he has been approached or pressed to do so. If, therefore, any reference is received on behalf of Government Servant from a dignitary/Member of Parliament, it would be assumed that it has been taken up only at the instance of the Government servant and action will be taken against him/her for violation of Rule 20 and instructions issued thereunder.

The employees of NYKS are therefore, advised to desist from approaching the MPs/VIPs for furthering their interest in respect of matters pertaining to his/her service under the Sangathan.

The employees of NYKS are hereby reassured that their representations submitted in the manner prescribed would receive the full and sympathetic consideration and the genuine grievances permissible under the rules would be redressed at the earliest.
